

Clean up after your dog

It is against the law to allow a dog in your control to foul in a public place and make no attempt to clean up after it.



Failure to do so may result in a £75 fixed penalty or prosecution (£1,000 max fine)

The Dangers of Dog Mess

Dog mess carries potential diseases to both humans and other dogs.

- Toxocara T.Canis is a potentially serious infection to humans which can cause very severe eye infection and in the most serious cases can make humans go blind. Children are at most risk.
- Parvo is a potentially fatal disease which is transferred between dogs

Pastroni pas qenit tuaj – Është kundër ligjit të lejohej qeni nën kontrollin tuaj që të fëlliqë në vend publik dhe të mos tentoni ta pastroni fëlliqësinë. Dështimi së pastruari mund të rezultojë në paralajmërim gjobe fikse prej £75.00 ose ndjekje penale (gjoba maksimale £1,000).

French

Assurez la propreté de votre chien – C'est contre la loi de laisser un chien à votre charge polluer les lieux publics, et de ne faire aucune tentative de nettoyer ses saletés. Si vous manquez à votre devoir, vous risquez une amende de £75.00 ou des poursuites légales (avec une amende de jusqu'à 1000 livres).

Polish

Posprzątaj po swoim psie – osoby, które zezwalają psom znajdującym się pod ich kontrolą zanieczyszczają miejsca publiczne oraz nie próbują po nich posprzątać, łamią prawo. Niedostosowanie się do tego grozi karą w wysokości £75.00 lub ściganiem sądowym (maksymalna kara £1,000).

Kurdish

Pîsîya kûçikê xwe paqij bikin – Heke hun bihêlin ku kûçikêkî di bin kontrola we de li cîhekî gelêrî pîsîyê bike û li dû wî paqijîyê nekin, ev li dijî qanûnê ye. Heke hun wanî nekin, dibe ku hun hişyarîya cezayêke peran a £75.00 bistînin, an jî doza dadgehê li dijî we vebe (ceza peran a herî pir £1.000 e).

Somali

Eygaaga saxaradiisa nadiifi – qaanuunka ayay ka soo horjeeddaa inaad eyga aad wadato inaad u oggolaato inuu ku saxaroodo goobaha caamka kadibna aanad saxaradiisa nadiiifin. Haddii aad sidaas yeeli waydo waxa laga yaabaa inay arrintaasi keento in lagu ganaaxo £75.00 lagugu xukumo (£1,000 ganaaxa ugu badan).

Turkish

Köpeğinizin pisliklerini hemen arkasından toplayın- kontrolünüzdeki bir köpeğin kamuya ait bir alana pislemesine izin vermek ve hemen temizlemek yasalara aykırıdır. Aksi takdirde hakkınızda 75 Sterlin sabit para cezası uygulanabilir ya da kovuşturma (Maksimum 1000 Sterlin para cezası) açılabilir.
