Dear Car Park User

The car park in Garman Road is owned by Haringey Council. As you may be aware, there have been some recent cases of misuse of the car park, including fly tipping, parked cars blocking access ways and other problems.

To make the car park safer and to meet the costs of maintaining the car park, Haringey Council is proposing to make some changes to the car park's management. Before we implement any changes we would like car park users to be able to have their say about the future plans.

We are proposing several changes, including regulating the number of cars parked in the car park, introducing a minimal daily charge for regular users, and introducing a more substantial charge for parking on match days at Tottenham Hotspur Football Club. Under the proposals, the parking regulations will also be enforced and the car park will be inspected on a regular basis by Haringey enforcement team.

We have identified several users of the car park including employees of local businesses, allotment holders and people attending football matches in the local stadium. We would like to consult with as many groups as possible over the next three weeks.

The options being considered are shown in more detail overleaf. We would like to give you the chance to comment and to propose your ideas for the management of the car park. There will also be an opportunity to discuss the proposals for the car park with the Parking Team at the car park on Tuesday 12 June from 12.30pm until 5.30pm. Proposals for Garman Road Car Park charging structures

Cars displaying disabled parking permits park free at all times.

Match day and evening match parking rates:

Pay and display option: Parking charges from one hour before kick off.
Rate will be £2 per hour. Pay and display tickets purchased from machine.

Alternatively a season ticket covering all home games could be purchased at a cost of £35.

Non-match evenings and weekends: no charge

Weekday rates

The weekday rates will be minimal and designed to cover the cost of running the car park and the scheme.

Some suggestions include:

Pay and display machine dispensing tickets by the hour for casual users at 50p per hour with a maximum of £3 per day

Or a more structured scheme: for example:

Monthly ticket, no guaranteed space: £25

Quarterly season ticket, no guaranteed space: £75

Annual ticket entitling the user to a reserved space: £120 per year
