## Information Letter

### Implementation of Crouch End A and Stroud Green Controlled Parking Zone (CPZ) Extension

Dear Resident or Trader,

You may recall our notification letter in July 2011 proposing to extend the Crouch End 'A' and Stroud Green Controlled Parking Zone (CPZ). We received extensive feedback, and on behalf of the Council, I would like to thank all those who took time to have their say and make their views known.

A majority of the representations from the proposed extended areas supported the proposals and the Council has therefore decided to go ahead and implement the Crouch End 'A' and Stroud Green CPZ which include roads as indicated on the plan overleaf. The operating hours and days of the schemes are also listed on the attached plan. **The CPZ extension will go live on 12 December.**

Feedback to the notification shows that many residents of roads immediately outside the proposed CPZ extension are concerned with the potential parking displacement likely to result. Some residents used this to argue against further CPZ extension, while others requested that their road should be included in any extension (so that their roads would not experience displacement parking).

### Tell us about parking prospects in your road



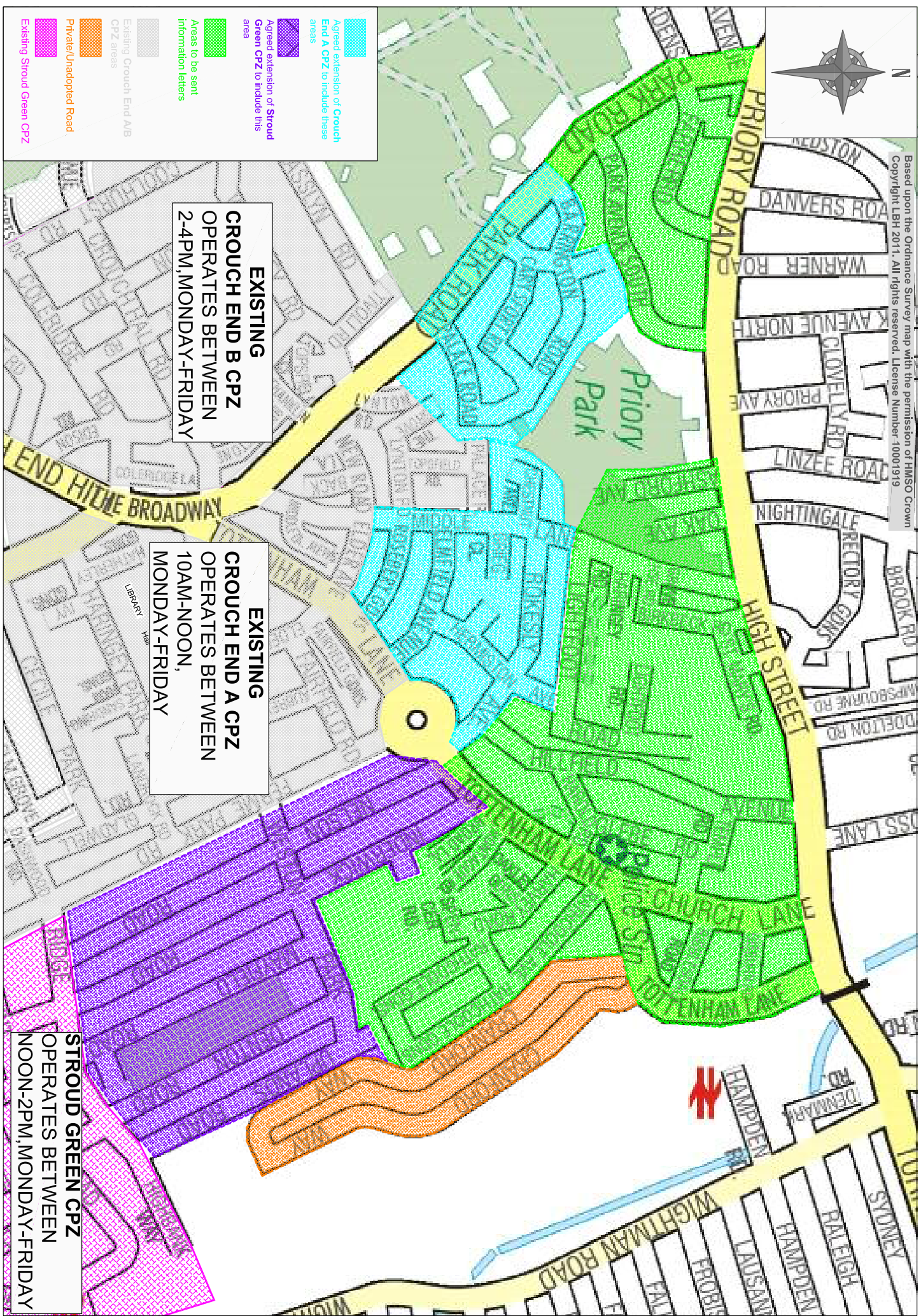
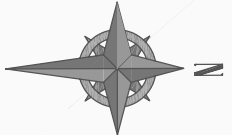
