I wish to comment on the Update to Haringey's Employment Land Study 2012, with reference to the Council's proposed redesignation of DEA 6.

Haringey Council's deeply disingenuous pretence at even-handedness in the matter of the proposed NLWA waste processing site at Pinkham way is now fully exposed as a sham. The very naming of the site in this report is evidence of the Council's bias: in the Update, the site is called "Friern Barnet Sewage Works" when of course the use of the site for the purpose of sewage processing ceased almost 50 years ago. An equally accurate and honest use of English would be to describe Coppett's Wood N10 as "Muswell Hill Army Base". Why has the crucial word "Former" been removed from DEA6's title, as used in all previous Haringey documentation? Because, of course, Haringey wish to pretend that this is a "brownfield" site and gloss over its nature conservancy importance.

There is no mention whatsoever of the Council's admission that the redisignation was made at least in part specifically to facilitate the implementation of the North London Waste Plan.

Haringey's devious, biased and secretive handling of the NWLA plan means that it must not be allowed to bring local government into even further disrepute by being the deciding body over such a highly contentious planning application in which it is a joint applicant. The attempt through propaganda such as the Update to retrospectively legitimise its re-designation of DEA6 offers further proof.
