STATUTORY NOTIFICATION

Proposed Electric Vehicle (EV) Recharging Points

Dear Resident or Trader

As part of the council's commitment to encourage use of electric cars, we propose to provide electric vehicle (EV) recharging parking bays at the following locations in the borough:

- **Shepherd's Hill, N6** - 2 bays, on the south side, approximately 90 metres from the junction of Archway Road.
- **Durnsford Road, N11** - 2 bays, on the north-west side, outside Nos. 34 and 36 Durnsford Road.
- **North Road, N6** - 2 bays, on the west side, outside No. 33 North Road. The existing residents' bays will be reclassified as EV recharging bays.
- **Fortis Green, N2** - 2 bays, on the south side, outside the Clissold Arms Public House.

Locations for EV recharging points have been chosen on the basis of a survey carried out by Transport for London (TfL) to identify likely locations of potential EV users, and in consideration of implications for public safety. Further details are shown on the plan overleaf.

Interest in electric cars is growing as they are cheaper to run than petrol vehicles, and the council wants to ensure that existing and new users have ready access to recharging facilities.

This notification letter marks the start of a three week period during which we welcome your views and comments on the proposal. At present the recharging points in Haringey are available to local residents. However, in April 2011 a new pan-London electric vehicle recharging membership scheme called 'Source London' will replace Haringey's scheme. The new scheme will enable EV users to park and recharge at any on-street and public car park electric recharging point in London.

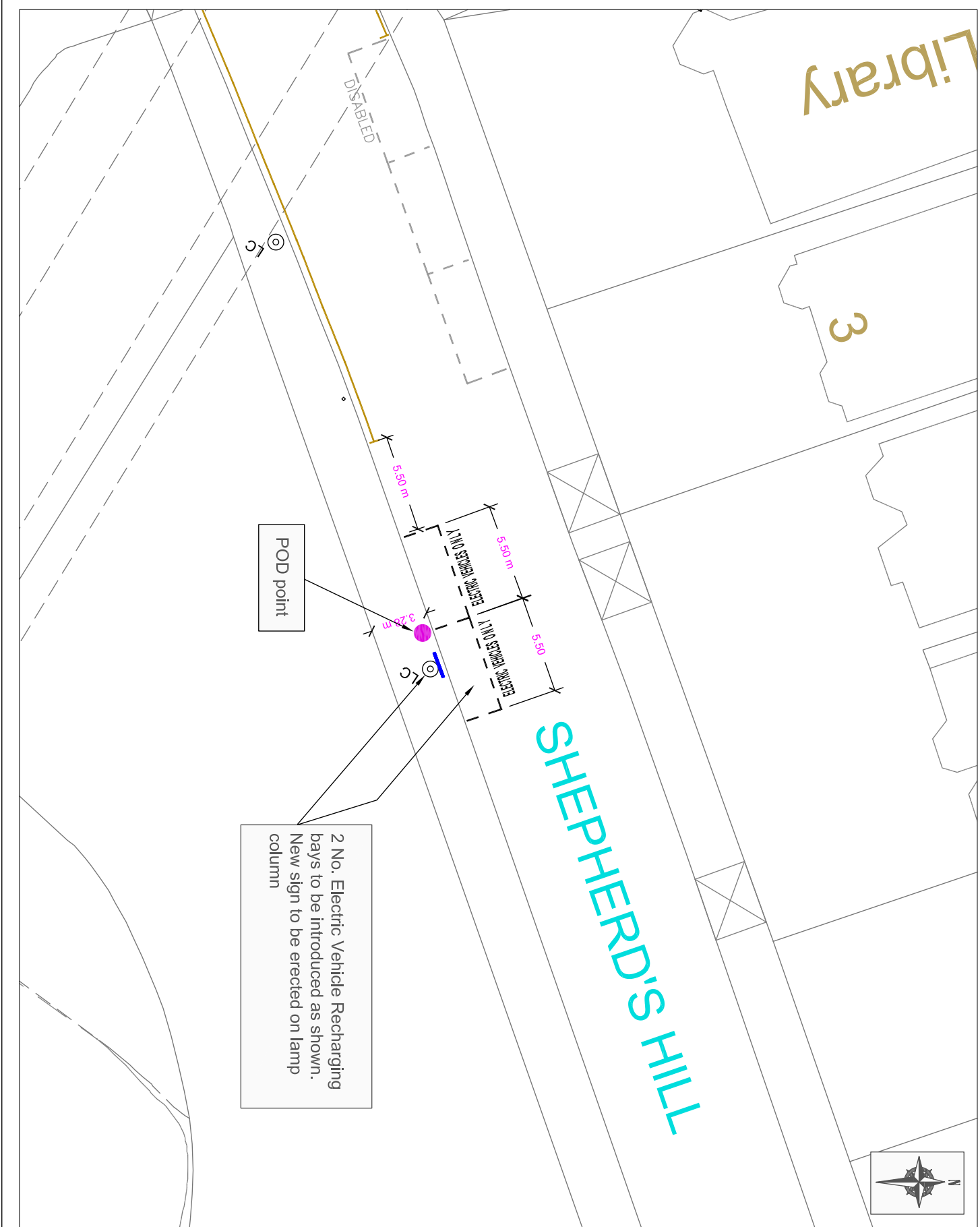
