## Extending Street Drinking Prohibited Zones

Haringey Council would like your opinion on its proposals to extend the existing Street Drinking Prohibited Zone in St Ann's Ward.

The map overleaf shows the existing zone, where the police have additional powers to prevent street drinking **if this is linked to anti-social behaviour**. As a result of these extra powers, we have found that anti-social behaviour resulting from street drinking has been displaced to St Ann's ward, particularly in the areas shown on the map **in red**.
