

GUIDANCE FOR STREET TRADERS

ICE CREAM TRADING IN HARINGEY

Haringey Council does not issue Street Trading Licences in respect of Ice Cream Sales (except at approved Street Festivals).

'Ice Cream' includes goods that are wholly or mainly ice cream, frozen confectionery or other similar commodities.

People who own ice cream vans may trade as 'itinerant traders', going from place to place remaining in any one location in the course of trading for periods of 15 minutes or less and not returning to that location or any other location in the same street on the same day.

This means you can travel down many streets of the Borough, briefly sound your chimes and await people coming out of nearby properties to make a purchase. Once the queue of customers have been served you shall move further along the road or to the next street to repeat the procedure.

However, there are some roads in which trading is not permitted. A complete list appears overleaf.

People trading from the traditional stop-me-and-buy-one tricycle or the like are also subject to the same conditions.

If you leave the vehicle parked and travel on foot say with a small frozen cabinet, you would still infringe the Regulations.

If you are delivering house-to-house or by order by phone or by internet than you do not infringe the law if you deliver to the door and take the cash or cheque payment on the householder's property.

Even if you find private land to trade from with the written permission of the landowner, you would have to get at least 7 metres away from the nearest footway or roadway.

Traders convicted of unlicensed street trading face a daily fine up to £1,000. If you are seen trading after being convicted in the Courts, Police and Council Officials can seize the vehicle and it is up to a Magistrates' Court whether or not you get it back.

PROHIBITION OF ITINERANT ICE CREAM TRADING

NOTICE IS HEREBY GIVEN that the Council has passed a resolution under Section 37(2) London Local Authorities Act 1990, prohibiting itinerant Ice Cream Trading in certain streets, varying the prohibited list in force since 15th August 1992.

'That in accordance with Section 37(2) of the London Local Authorities Act 1990, itinerant ice cream trading shall be prohibited in the following streets, or those parts of the streets in Haringey'.

These shall take effect from **1st April 1998** being 28 days or more after the first appearance of this Notice.

- (a) Wood Green High Road between Turnpike Lane and Bounds Green Road.
- (b) Green Lanes between the Borough boundary and Turnpike Lane.
- (c) Tottenham High Road.
- (d) Bruce Grove
- (e) Lordship Lane
- (f) The Roundway
- (g) Great Cambridge Road
- (h) Archway Road
- (i) Muswell Hill
- (k) Muswell Hill Broadway
- (l) Park Road
- (m) Stroud Green Road
- (n) Bounds Green Road
- (o) Crouch End Broadway
- (p) Seven Sisters Road
- (q) Priory Road
- (r) Turnpike Lane
- (s) Hornsey High Street
- (t) Westbury Avenue
- (u) Muswell Hill Road
- (v) Colney Hatch Lane
- (w) Crouch Hill
- (x) Crouch End Hill
- (y) Tottenham Lane
- (z) Ferry Lane
- (aa) Watermead Way
- (bb) Broad Lane
- (cc) Those parts of any side street of any of the above mentioned streets lying within 50 metres of the junction with the said street (a-bb)
- (dd) those parts of any street within 65 metres of any exit used by children from the following premises:
 - (i) Primary Schools
 - (ii) Under 5 Centres
 - (iii) Day Nurseries
 - (iv) Secondary Schools
 - (v) Special Schools
