| <b>General Effect of Order</b> –<br><b>Road Closure and No Waiting/Loading within 20 metres of the following locations:-</b><br><br><b>Bounds Green Road</b> , N11 - junctions with Cline Road, The Drive, Blake Road, Passmore Gardens and Gordon Road; <b>Blake Road</b> , N11- junctions with The Drive, Torrington Gardens, Churston Gardens, Lynton Gardens; <b>Bidwell Gardens</b> , N11 – junction with Winton Avenue; <b>Woodfield Way</b> , N11 – junctions with Lynton Gardens, and Durnsford Road; <b>Gordon Road</b> , N11 - junction with Passmore Gardens/Edwards Drive; <b>Wroxham Gardens</b> , N11 – junction with Durnsford Road.<br><br><b>No Waiting/Loading restrictions within 10 metres of the following locations:-</b><br><br><b>Bidwell Gardens</b> : outside Nos. 2 and 4; <b>Churston Gardens</b> : (a) outside No. 2; (b) outside Nos. 16 and 18; (c) outside Nos. 32 and 34; <b>Durnsford Road</b> : outside Nos. 41 to 69; <b>Gordon Road</b> : outside Nos. 4 and 6; <b>Torrington Gardens</b> : (a) outside No. 2a; (b) outside Nos. 14 and 16; (c) outside No. 31; <b>The Drive</b> : (a) outside No. 6; (b) outside Nos. 15 and 16; (c) outside Nos. 24 and 25; <b>Lynton Gardens</b> : outside No. 12; <b>Passmore Gardens</b> : (a) at the side of Warwick Court, Bounds Green Road; (b) outside No. 9; (c) outside No. 19; <b>Woodfield Way</b> : (a) outside Nos. 22 and 24; (b) outside Nos. 15 and 17; (c) outside Nos. 56 and 58; (d) outside Nos. 80 and 82; outside No. 96; (e) outside No. 39; (f) outside No. 49; (g) outside Nos. 152 and 154; (h) outside Nos. 116 to 128; (i) at the side of No. 19 and No. 40 Durnsford Road. |
