NOTICE IS HEREBY GIVEN that the Council of the London Borough of Haringey on 5th July 2024 has made the above mentioned Order under Section 29 and Part IV to Schedule 9 of the Road Traffic Regulation Act 1984, as amended.

The general effect of the Order would be to introduce a play street for the purpose of enabling the road to be used as a playground for children and to prohibit any vehicle from entering or proceeding in Connaught Road N4 from No. 1 Connaught Road (Junction of Lancaster Road) to No. 35 Connaught Road (Junction of Churchill Court flats) between the hours of 1pm and 4pm on the last Sunday of every other month, throughout the year except if falls on Christmas day in which it will be the Sunday before

The Order would not apply to any vehicle requiring access to a property within the closed section of road providing that vehicle is travelling at a speed of no more than 5 m.p.h. and is supervised by an adult in high visibility clothing.

Date of operation: The Orders will come into operation on 15th July 2024.

Application to the high court: Any person desiring to question the validity of the Orders or of any provision contained therein on the grounds that it does not comply with the relevant powers of the Road Traffic Regulation Act 1984, as amended or that any of the relevant requirements thereof or of any relevant regulations made there under have not been complied with in relation to the Orders may, within six weeks of the date on which the Orders were made, make application for the purpose to the High Court.

Coming into operation: 15th July 2024

The Council of the London Borough of Haringey, after consulting the Commissioner of Police of the Metropolis, in exercise of the powers conferred by section 29 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984¹ as amended by the Local Government Act 1985² and the Traffic Management Act 2014³ and of all other powers thereunto enabling, hereby make the following Order:

Citation and commencement

1. This Order may be cited as the Haringey (Moving Traffic Restrictions) (Amendment No.13) Order 2024 and shall come into operation on 15th July 2024.

Interpretation

- (1) In this Order, unless the context otherwise requires: "the Order of 2021" means The Haringey (Moving Traffic Restrictions) Order 2021
 - (2) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
 - (3) Unless the context otherwise requires, any expression used in this Order which is also used in the Order of 2021 shall have the same meaning as in that Order.

Amendment to the Order of 2021

3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, the Order of 2021 shall have effect as though the item specified in the schedule to this order be added to Schedule 5 to that Order.

Play Street

4. (1) Except as provided in Article 16(4) of the Order of 2021, no person shall cause any vehicle, other than a non-mechanically propelled vehicle pushed by a pedestrian, to enter into or proceed in a length of road specified in column 1 of the Schedule between the times specified in column 2 of the said Schedule subject to a play street no vehicles prohibition, and by the aspect of a traffic sign of the type shown in Item 11 of Schedule 3, Part 2 to the Traffic Signs Regulations and General Directions 2016 and a traffic sign placed in association with that traffic sign indicating that said length of road is a play street, during the hours of operation of that play street no vehicles prohibition.

(2) The provisions of the Order of 2021 shall apply to play street specified by this Order as if in those provisions any reference to a play street included a reference to the play street introduced by this Order and as if any reference to Schedule 5 to the Order of 2021 included a reference to the Schedule to this Order.
