We will be holding two drop-in sessions at St Mary's CE Primary school. These give residents the opportunity to talk through the proposals and raise any questions with our Engineers. Details of the two sessions are:

- Saturday 18 November from 11am - 2pm
- Wednesday 22 November from 6pm - 8.30pm.

Parking engineers and managers will study the consultation results in detail before recommending if parking controls should or should not be introduced. We will analyze the responses on a road by road basis and if your road says no but adjacent roads say yes, your road could be excluded from any future scheme. Consultation results will be published on the parking consultations page of the website.
