## Outcome of Statutory Consultation and Works Notice

Installation of Electric Vehicle Charging Points (EVCP's) at various locations in the borough

Dear Resident or Business,

In response to requests from local residents, you may recall that we consulted you in February/March 2018 regarding the possible introduction of 75 Electric Vehicles Charging Points (EVCP's)/bays at 23 locations in the borough. A statutory consultation letter including plans was sent to all residents who contacted us requesting EVCP's to be installed in their street/area. The letter – dated 23 February 2018 was also delivered to all properties in the vicinity of the proposed bays. The consultation closing date was 16 March 2018. We received a good response to the consultation and on behalf of the Council, we would like to thank all those who took the time to have their say and make their views known.

As part of the decision-making process, the Cabinet Member has considered all representations and has now approved the introduction of EVCP's at the locations listed at the back of this letter and indicated on the attached plan. The latest information from Transport for London study, it's predicted that Haringey will need to provide 152 EVCP's in near future and the installation of these EVCP's is in line with the councils agreed Transport Strategy to encourage the uptake of electric vehicles and to contribute to our commitment to improving air quality.

These charging points will be part of the Source London network and will be accessible to Source London members and all other users on 'pay as you go' bases. The installation works for the EV charging points will be carried out over the next two months and we expect all the charging points to be operational before the end of December 2018.

Residents should be aware that the bays are to be used for Electric Vehicles Charging only. Unauthorised vehicles may receive a Penalty Charge Notice (PCN) and be subject to removal.

This is Phase 1 of our EVCP expansion programme, based on the uptake of these charging points after implementation, the council will be considering additional locations as part of a Phase 2 programme.
