## Review of Bruce Grove West Controlled Parking Zone (CPZ)

Dear Resident or Business,

Bruce Grove West CPZ operating days and times are Monday – Friday 2pm to 4pm. We are currently reviewing Bruce Grove West and we would like to hear your views on how the parking controls are working or whether you think any changes are needed. For example, are the current operating hours sufficient to deal with parking problems, or should they be extended in general, or perhaps on match / event days only. Some CPZs have longer hours applying just on match / event days.
