## Public Consultation

### Review of the Highgate Controlled Parking Zone (CPZ) Area.

Dear Resident or Business,

Periodically, the council conducts reviews of CPZs to ensure they are working effectively and that there is adequate parking space for local residents. We also review parking in local shopping and service areas to ensure there is parking available for shop, restaurant and other business customers and visitors.

Since the introduction of the Highgate Station CPZ there has been a significant reduction of congestion caused by commuters leaving vehicles parked in order to use the Underground and buses to travel to central London for the daily commute. To ensure the scheme is still delivering improved parking availability to local residents and businesses the council periodically undertake a review to ask the local community for their views and understand whether there is a desire to adjust any aspects of the operational features of the scheme.

### Have your say

Our intention for this consultation is to hear your views on the effectiveness of the current parking controls and whether there is a need to adjust the current operating days and times or make any other changes to better meet residents and business needs.

It should be noted that residents who live in a car free development will not be eligible to apply for parking permits to park in the proposed Highgate CPZ area. Homes for Haringey residents are eligible to apply for parking permits.
