

Withdrawal and Revocation of the London Borough of Haringey  
Supplementary Planning Guidance and Documents –  
Statement of Fact

In accordance with Town and Country Planning (Local Planning) (England) Regulations 2012, pertaining to the Planning and Compulsory Planning Act 2004, withdrawal of a supplementary planning document must follow some requisite steps, including where a supplementary planning document is withdrawn pursuant to section 22 of the Act, the local planning authority must make a statement of that fact available as soon as reasonably practicable.

This document represents a **Statement of Fact** in accordance with the above regulation, and explains why the documents and guidance have been withdrawn.

In addition, it outlines the reasons Haringey Council has sought permission from the Secretary of State to revoke certain supplementary planning documents.

Supplementary Planning Guidance and Documents Withdrawn

On 15 July 2014 and in accordance with relevant regulations, the Cabinet of the London Borough of Haringey decided to withdraw the certain un-adopted planning guidance documents. These guidance documents, the dates drafted, their purpose and comments on their withdrawal are contained in the table below.
