Analysis of feedback cards from residents.

Out of the 33 responses received, thirty, or ninety one percent, supported the proposals and three, which is nine percent objected to it.

Gaskell Rd	1. Support	People who don't live here leave their cars and go on holiday (or away) - sometimes for weeks. Please make it affordable for residents

This is worst at times when children are in the playground - toxic pollution levels are therefore very high. If you are planning some spaces for school staff, Storey Rd is too small to cope.
