Thank you for your email.

Perhaps you would direct your line manager to the following paras of the Inspector's report - para 18: "It must also be recognised that forthcoming planning documents, such as the Sites Allocation DPD and Area Action Plans (AAPs) will provide greater detail on the delivery of the strategic aims and will invariably engage with all relevant stakeholders, including the local communities affected."

and para 62 (re Pinkham Way specifically) "Mindful of the considerable public interest in the use of this site, this would be a further opportunity to engage appropriately with all relevant parties."

With regards the stage 1 "Haringey Strategic Flood Risk Assessment" contained in the NLWP. Unfortunately this assessment did not comply with the NPPF and is therefore valueless.

The preliminary local flood risk management strategy should have been available from 2011 and a summary of it should already be published. However I will raise this point with Mr Drew-Smith.
