

Blue Badge Organisations Guidance and Application Form



Please send your application form along with a copy of your organisation's prospectus to:

An administration fee of £10 is charged for each Blue Badge once you have received notification that your application has been successful. This must be paid by cheque or postal order made payable to the London Borough of Haringey.

An organisational badge will be issued to an organisation whose responsibility includes the care and transportation of disabled people, who would meet the criteria for a badge should they apply.

In all circumstances, badges will be issued supplied to organisations rather than to individual staff members. The badge can only be used when disabled person(s) are present and misuse can constitute a criminal offence.

Organisations applying for a badge should cater for an adequate number of people with the required degree of disability.

The person completing this form must sign and date it. This person will be the main contact for the organisation and solely responsible for the use and care of the badge and must be in a position to inform the borough (if requested), who is using the badge at any given time or place.
