Works Notice and Outcome of Statutory Consultation Bruce Grove North Merger

Merger of Bruce Grove North and Bruce Grove CPZs

Dear Resident/Business,

I am writing to let you know that we shall soon be merging the existing Bruce Grove North and Bruce Grove Controlled Parking Zones (CPZs) to become one overall Bruce Grove North zone. This letter is to inform you on how this merger is going to take place, along with important dates in the coming weeks for the merger of the Bruce Grove North and Bruce Grove CPZ's.

Parking consultation feedback

In March 2019, we carried out a review of both zones and consulted with the community, this received a number of comments and suggestions. As part of this review, we also asked residents and businesses if they would be in favour of combining the Bruce Grove and Bruce Grove North CPZs to become one overall zone. A majority of those who responded supported this proposal.

In response to your feedback we amended our plans before carrying out a statutory consultation in August 2020. A total of 8 representations were received during the statutory consultation period.

Way forward

Following discussions with your Ward Councillors, and the Cabinet Member for Transformation and Public Realm Investment Neighbourhoods, it has been agreed to merge the Bruce Grove North and Bruce Grove CPZs. As a result of this, the Bruce Grove CPZ will now adopt the operational times of the Bruce Grove North CPZ including extended operating times on event days. The operational times will be:

- (Non-Event Day) Monday to Saturday 8am-6.30pm
- (Event Day) Monday to Friday 8am-8.30pm ;Saturday & Sunday 8am-8pm;
Public Holidays noon-8pm

During the consultation, concerns were raised by your Ward Councillors that there were not sufficient shared use or pay by phone parking facilities for visitors to attend community activities and businesses in the area. Therefore, to help visitors, we will be installing a number of additional shared-use (permit holder or Pay by Phone) parking bays close to shops, businesses, schools, parks and places of worship.

Important dates

Works to change over the existing signs in the Bruce Grove area will begin on Monday 8 March 2021 and this will include adjustments to signs and some posts. This should take approximately 3 weeks to complete, subject to the weather. We will make every effort to minimise traffic disruption while the work is in progress.

Resident permits & visitor vouchers

For all existing permit holders, there is no need for you to change your permit at this time. Your current permits for Bruce Grove and Bruce Grove North will be valid for parking throughout the extents of the new zone boundary. If you are a holder of a Bruce Grove Permit, when it is time to renew your permit, you will now be required to purchase a Bruce Grove North permit.

If you only need visitor vouchers you will still need to register with us first. To apply for visitor vouchers please visit www.haringey.gov.uk/parking where you will be asked for your Council Tax reference number. If you do not have that available, you will need to attach a document showing proof of your address (excluding mobile phone bills).

We aim to complete your registration for visitor vouchers within five working days and will provide you with the unique login details that will let you purchase visitor vouchers online. You can use these details to purchase visitor vouchers online at any time in the future.

Resident parking permits and visitor vouchers purchased online will be sent by post within five working days of the transaction date.

Blue Badge Holders

The way you can use a blue badge or Companion Badge is not changing at present. Both of these will still be recognised and are valid when displayed in the windscreen of the vehicle, in a residents only, residents shared use, permit holder only, or a standard disabled parking bay.

In response to parking pressures in the Borough and disabled residents finding it difficult to access disabled parking bays, the Council introduced a dedicated disabled parking bay scheme in January 2020. A dedicated disabled parking bay which is for the exclusive use of one vehicle will be installed at the request of residents who meet the established criteria. If you choose to apply for this and are successful, you will be issued with a dedicated disabled bay permit to display in your vehicle. This will have a unique bay number for your location which will match with the bays sign giving the holder of the permit sole use of the parking place.

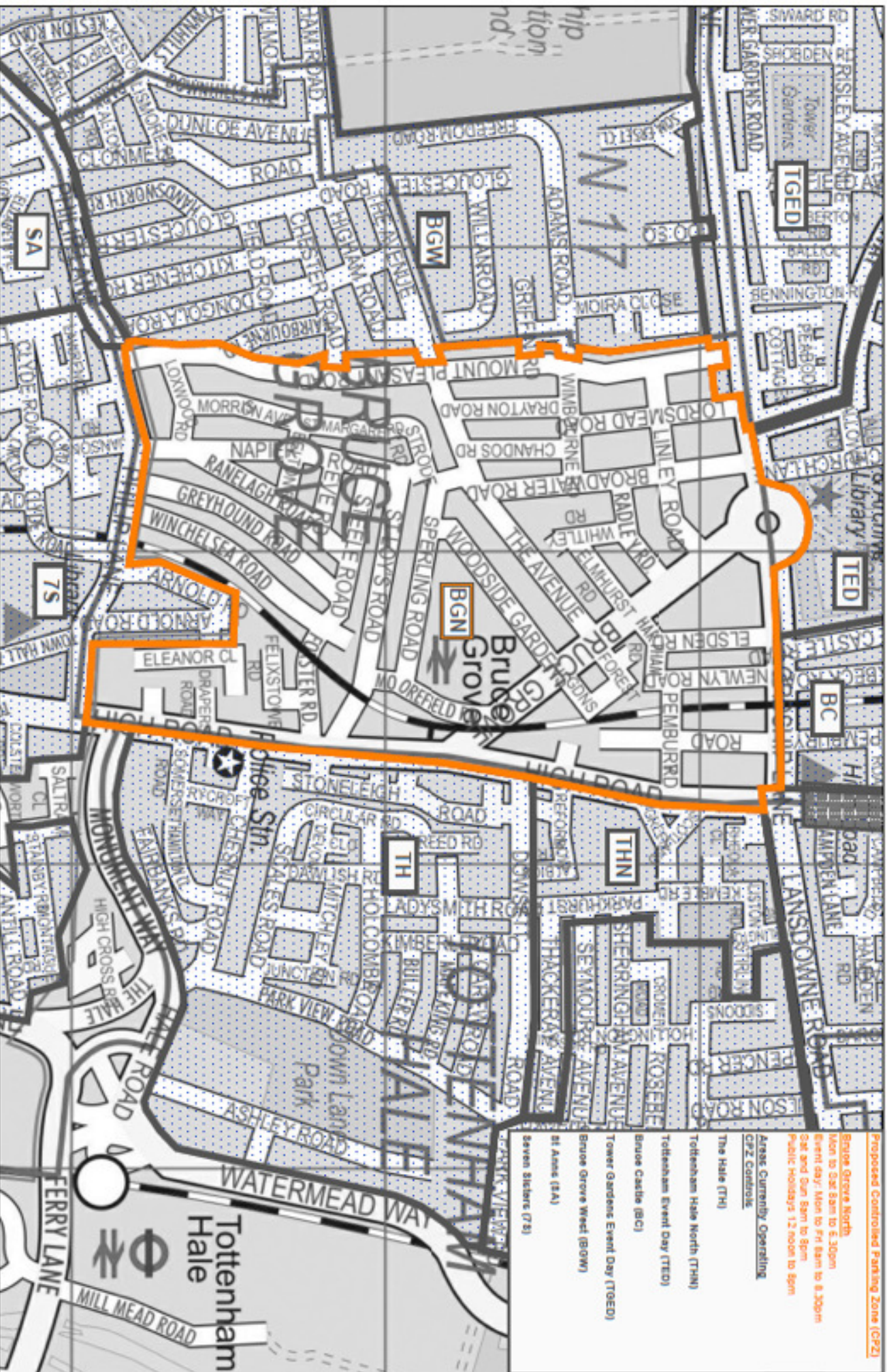
