Please also note the Matters & Issues for the Tottenham Area Action Plan (TAAP) will be published shortly. A later date for replies will be given as the hearing sessions for the TAAP will not be until 6 September 2016.

A number of you have also indicated you will be submitting an additional statement for specific sessions. Please ensure the required format has been followed. **If you already submitted your additional statement, but have not followed the Inspector's instructions which are set out below, please resubmit your statement again by the 29th July.** This is important to ensure that, as there are four Plans being examined, the statements can be allocated to the correct Plan, representor and matter/ issue.

An electronic copy of your statements and appendices (in Word or PDF format) will be acceptable.

In order for the Inspector to accept your submission, it is important the evidence submitted complies with the Guidance Note which provides a clear outline of what is required.

In brief, your statement should **not** be more than 3000 words, and be accompanied by a letter or front sheet identifying:-

- a) Your name;
- b) Your representor reference ID;
- c) the name of the plan it relates to;
- d) the name of the policy and which matter/issue they relate to;

- e) The letter or front sheet should also tell the Inspector how the evidence relates to the tests of soundness of the plan. (These are set out in the guidance relating to the Inspector's Matters and Issues).

With regards to finding your "Representor Reference" ID, below is the link to the submission library for the examination of the Local Plan on the Council's website. The responses to each of the Local Plan documents can be found at items 18, 19, 20 and 21, which includes the Council's response to each of the comments raised. Otherwise, at item 23 is a copy of each the representations as received.
