

# Enforcement action results

## March

### 31 March 2017

- A man who [dumped piles of rubbish in the street while disguised as a council worker](#) was found guilty at crown court of fly-tipping. Roy Thompson, 52, was wearing a Haringey Council hi-vis vest when he was spotted by a council manager ditching the waste beside a Texaco garage on White Hart Lane on 18 August at 9.15am. Thompson is now wanted by police after he failed to attend his trial.

### 27 March 2017

- The owner of a Tottenham mini market has been fined £3,600 for repeatedly selling illicit cigarettes from her shop in a case brought by Haringey Council's Trading Standards Service. The owner pleaded guilty to 8 charges at Tottenham magistrates court for possessing cigarettes with health warnings which did not comply with UK requirements. The owner was ordered to pay costs of £1,036 and a £45 victim surcharge.

### 23 March 2017

- Our enforcement team worked with police in a borough wide operation, seizing six vehicles responsible for around £20,000 worth of outstanding fines.

### 16 March 2017

- A resident in Tottenham was given a £400 fine for fly-tipping in their street. The resident also got a community protection warning letter about waste in the garden. Our officers returned the next day and everything had been cleaned up.

### 9 March 2017

- An off licence in Wood Green had its licence suspended for 6 weeks for stocking illicit vodka. The designated premises supervisor was removed.

## February

### 24 February 2017

- A bar that stayed open beyond its hours and caused noise problems for neighbours lost its late licence following a ruling by Highbury magistrates. The Pride of Tottenham, on the High Road, also known as N17 Lounge, had appealed against the council's decision to move closing time forward from 4am to 12.30am on weekends and 11.30pm Sunday to Thursday, but it was upheld.

21 February 2017

- The owner of an Alsatian guard dog was prosecuted over its barking, and for letting it roam freely at night at a commercial premises in Wood Green. The owner will be sentenced by Highbury magistrates.

9 February 2017

- Eight businesses on Tottenham High Road were each fined £400 for fly-tipping in one morning.

## January

27 January 2017

- A woman who made her neighbours' lives a misery with nuisance noise was prosecuted by Haringey's enforcement team. Beverley Sinclair has faced a string of actions, including successful prosecutions, over more than 10 years and has now been given a criminal behaviour order for breaching a noise abatement notice. Any breach of the order could lead to her being imprisoned.
