Presentation	Very well presented with lots of interesting facts. Good use of pictures and maps.	This plan isn't presented in the uniform way of other plans and is quite lengthy, it would be worth monitoring how efficient a lengthier plan is when it is reviewed. Consider if the images and tables content page, make it look more of an academic document rather than for general consumption. There is confusing information regarding TCV in one area you mention that they haven't worked in the area since 2014 and then you later mention how much work they did last year.

As it appears to be an asset, I would have expected the Shell theatre to be more explicit in the sites mission statement, as its seen as a key heritage feature with its own objectives. An action plan should be just that, aspirations about what you want to achieve. When you have words like annually, daily it is a maintenance schedule. It should also contain some dates to be effective.
