- (a) The general effect of the Order, in conjunction with the Haringey (Bounds Green East CPZ) (Section 6) (Amendment No. 1) Order 2021, is to remove an existing resident permit holders parking space in Marquis Road N22, located to the rear of Nos. 453 and 455 High Road N22 and replace it with single yellow line waiting restrictions operating at zone hours in order to facilitate the installation of vehicle a crossover outside of this property.






