Good afternoon,

I am formally submitting my objection to the proposed plans for the redevelopment of the Haringey Civic Centre car park. My school sits behind the Civic Centre and the wall of the car park is shared with the infant playground at my school.

Although I agree in principle that this is a good site for redevelopment. Trinity Road is already a very busy road and the entrance to the infant playground is on Trinity Road. Children use this entrance from 8.30-9.05 and 3.10-3.40 everyday and the current civic centre car park entrance is already dangerous as it is right next to the school entrance (I have formally raised concerns around this with Haringey council on several occasions). I am concerned that if development does take place, access to the site on Trinity Road would cause an even greater risk to the children entering and leaving my school.

Further objections would be: -

- As the playground behind the car park walls holds my infant playground this in use all day long and the building work noise and particularly dust will create a health risk to the children playing.
- Buildings that are agreed on the current car park could potentially over-look the school and the infant playground. If they did over-look the school playground it would create a major safeguarding risk.

We are of course happy to work with developers to ensure that the regeneration of this area does take place, however with careful consideration on the impact it could cause on the school and the children that attend it.

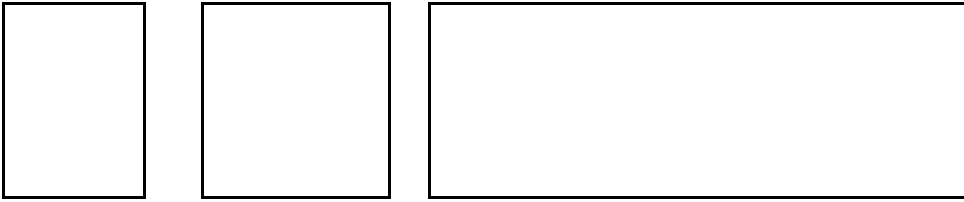
